### **Travel for EACH to provide Capacity Building Supports (Therapy Supports, Childhood Intervention Services, Support Coordination, Recovery Coach)**

EACH will charge Provider Travel costs at the value of the service delivered (time) plus at \$1.00 per kilometre (mileage) only when:

- EACH has the agreement of the Customer in advance i.e. the Quote outlines all maximum Provider Travel costs that may be charged;
- The Support Catalogue indicates that EACH can claim for Provider Travel in respect of that support item;
